Candidates are required to produce a Proof of Identity issued by Govt. **(in original)** such as Aadhar Card/Passport/Driving License/PAN Card/Voter Card etc. without which the candidate will not be permitted to appear for the Skill and written Test. No photocopies of the above documents shall be entertained.
2. Candidates are required to bring all the **original** Educational Certificates, Mark-sheets, testimonials, experience certificates, category certificates (SC/ST/OBC/PWD/EWS) and any other relevant documents as mentioned in the Application Form. During actual verification of original documents, if any discrepancy is noticed, candidate/ candidates will not be allowed to appear for the Skill Test and Written Test.
3. Candidates are requested to bring a '**No Objection Certificate**' from the employer, in case he/she is employed in a Government, Semi-Government, Autonomous Organization including Public Sector Undertakings etc. and whose application has not been forwarded through proper channel by the employer for this post. In the absence of **No Objection Certificate**, the candidature shall not be considered.
