If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 7. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Malicious Code Certificate:

The seller should upload following certificate in the bid:-

(a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :-

(i) Inhibit the desires and designed function of the equipment.

- (ii) Cause physical damage to the user or equipment during the exploitation.
- (iii) Tap information resident or transient in the equipment/network.

(b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.

3. Purchase Preference (Centre)

If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. 4. Purchase Preference (Centre)

The bid clause regarding "Preference to Make In India products" stands modified in this bid and shall be governed by the PPLC Policy No. FP-20013/2/2017-FP-PNG dated 17.11.2020 issued by MoP&NG as amended up to date. Accordingly, bidders with Local Content less than or equal to 20% will be treated as "Non Local Supplier". The prescribed LC shall be applicable on the date of Bid opening. Sanctions on the bidders for false / wrong declaration or not fulfilling the Local Content requirement shall be as per the PPLC policy. Further following additional provisions are added in the certification and verification of local content provision of the Preference to Make in India clause:

- i. In case of foreign bidder, certificate from the statutory auditor or cost auditor of their own office or subsidiary in India giving the percentage of local content is also acceptable. In case office or subsidiary in India does not exist or Indian office/subsidiary is not required to appoint statutory auditor or cost auditor, certificate from practicing cost accountant or practicing chartered accountant giving the percentage of local content is also acceptable.
- ii. Along with Each Invoice: The local content certificate (issued by statutory auditor on behalf of procuring company) shall be submitted along with each invoice raised. Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

5. Payment Term : 100% payment will be made after delivery, installation & satisfactory acceptance by th e user subject to submission of all requisite clear documents i.e PBG 10% of total order Value valid till 38 months from the date of installation, Delivery Challan certified with exact date of supply by the consignee, Original Tax invoice, Warranty Certificate, Installation Certificate etc. If the supplier fails to submit the PBG , Institute will release 90% payment and balance 10% will be released after completion of warranty period + 2 months only.

6. DELIVERY WITH INSURANCE: The date of delivery should be strictly adhered to failing which the purchas e order is liable to be cancelled. Penalty may be imposed as per P.O. terms & conditions. Goods should be securely, safely and adequately packed, insured & dispatched at the risk of supplier and packing costs quo ting this order reference should be kept in all package. Local firms are requested to deliver the goods in o ur stores before 3.00 PM on any working day.

7. All damaged or unapproved goods shall be returned at your cost & risk and the incidental expenses incu rred thereon shall be recoverable from any of your bill. Availability of Service Centres: Bidder/OEM must ha ve a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bi dding, successful bidder / OEM shall have to establish one within 30 days of award of contract. 8. LIQUIDATED DAMAGES: As time is the essence of this order, the date of delivery & installation should be strictly adhered to, otherwise the delivery in full or in part may not be accepted and penalty for late delive ry will be imposed @ 0.5% of the contract value per week or part of the week of the delayed period, subjec t to a maximum of 10% of the total value of supply order .

9. CANCELLATION : Printed conditions, if any, contained in or sent along with the quotation shall not be bin ding on us. IIT Bhubaneswar reserves all the rights cancel the Purchase Order at any stage without assigni

ng any reason thereof.

10. JURISDICTION: This contract between the supplier and the buyer shall be governed by the LAWS of Indi a and under this contract shall be taken by the parties only in Bhubaneswar, India to competent jurisdictio n.
