If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-oflife by the OEM before this period.

4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

5. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

6. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

7. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

8. Buyer Added Bid Specific ATC

1. Bidders must submit the Similar Purchase Order copies executed in National Importance Institutions like, IITs, NITs, IISERs, NISER, Central Universities etc. Failure to submit the same, Bid may be rejected.

5. Payment Term : 100% payment will be made after delivery, installation & satisfactory acceptance by the user subject to submission of all requisite documents i.e PBG 10% of total order Value(if applicable), Delivery Challan, Original Tax invoice, Warranty Certificate, Installation Certificate etc. If the supplier fails to submit the PBG, Institute will release 90% payment and balance 10% will be released after com pletion of warranty period + 2 months only.

6. DELIVERY WITH INSURANCE: The date of delivery should be strictly adhered to failing which the purc hase order is liable to be cancelled. Penalty may be imposed as per P.O. terms & conditions. Goods sho uld be securely, safely and adequately packed, insured& dispatched at the risk of supplier and packing costs quoting this order reference should be kept in all package. Local firms are requested to deliver t he goods in our stores before 3.00 PM on any working day.

7. All damaged or unapproved goods shall be returned at your cost & risk and the incidental expenses i ncurred thereon shall be recoverable from any of your bill.

8. PERFORMANCE BANK GUARANTEE (PBG): The successful Bidder has to submit Performance Security of 10% of the total order value on or after commission of equipment. Performance Security must valid f or 38 (Thirty Eight) months i.e. 2 months beyond the warranty period to cover the warranty. Performan ce security is to be issued and sent directly from an Indian Scheduled/Nationalized bank. In case of non -submission of PBG, the equivalent amount will be kept on hold from the Bill amount till completion of Warranty Period + 2 Months. PBG period will start from the date of the installation.

9. WARRANTY : Ordered materials should have 03 Years onsite OEM Warranty from the date of installat ion/commission & acceptance by the user. In case at the time of installation of stores / part of stores ar e found defective / damaged during or after delivery to consignee or during warranty period, the suppli er will replace or repair the store under warranty at consignee's location in India free of cost or if any c ase it is required to send back to Foreign/Local manufacturer, supplier should bear the cost. Bank Guar antee equivalent to the cost of equipment is required to be submitted before lifting the store. All expe nses including freight, insurance, custom duty for export/import and all clearance charges etc. in this r egard will be borne by the supplier. The equipment under warranty period must be attended & proble ms rectified immediately within 48 hours of lodging of complaint by the Institute and this may be consi dered as the down time. The warranty period shall automatically be extended for such period for which the equipment is not attended & rectified on lapses of the down time.

10. INSTALLATION : Installation & demonstration should be done by the supplier within 30 days of supp ly of the equipment failing which purchase order is liable to be cancelled/penalty may be imposed as P

urchase Order terms and conditions. In case the item ordered for is a machine/equipment the same sho uld be successfully installed and commissioned immediately but in no case later than one month of the supply or the same. For delay in commissioning beyond 30 days scheduled period damaged as deemed appropriated may be deducted from the Bill / Agency Commission.

11. LIQUIDATED DAMAGES: As time is the essence of this order, the date of delivery should be strictly a dhered to, otherwise the delivery in full or in part may not be accepted and penalty for late delivery wi II be imposed @ 0.5% of the contract value per week or part of the week of the delayed period, subject to a maximum of 10% of the total value of supply order & beyond 10% subject to approval of the Comp etent Authority of the Institute. In case of delay in installation the same rate of penalty shall be leviabl e. In case of cancellation of order no compensation will be paid towards progress of order/procurement

12. CANCELLATION: Printed conditions, if any, contained in or sent along with the quotation shall not be binding on us. IIT Bhubaneswar reserves all the rights cancel the Purchase Order at any stage without assigning any reason thereof.

13. JURISDICTION: This contract between the supplier and the buyer shall be governed by the LAWS of I ndia and under this contract shall be taken by the parties only in Bhubaneswar, India to competent juri sdiction.

14. False declarations will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the General Fina Rules for which a bidder or its successors can be debarred for up to two years as per Rule 151 (iii) of the al Finance Rules along with such other actions as may be permissible under law.

15. Price break up must be provided by L1 Vendor after opening of the price Bid.
