1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be

exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. ## 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## 2. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-oflife by the OEM before this period.

#### 3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

#### 4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

#### 5. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

#### 6. Service & Support

#### 7. Service & Support

(a) Bidders must submit the Similar Purchase Order copies executed in National Importance Institu tions like, IITs, NITs, IISERs, NISER, Central Universities etc. Failure to submit the same, Bid may be rejected.

(b) Bidders must submit the Manufacture Authorization Form, Declaration for Local Content duly si gned by OEM as per Annexures attached. Failure to submit the same, Bid may be rejected.

(c) Bidder must submit the Bidder Details, Acceptance for Bid Terms and Conditions, Bid Securing declaration certificate and Vendor Master Form as per Annexures attached. Failure to submit the s ame, Bid may be rejected.

(e) Payment Term : 100% payment will be made after delivery, installation & satisfactory acceptance by the user subject to submission of all requisite documents i.e PBG 10% of total order Value(if applicable), Delivery Challan, Original Tax invoice, Warranty Certificate, Installation Certificate etc. If the supplier fails to submit the PBG, Institute will release 90% payment and balance 1 0% will be released after com pletion of warranty period + 2 months only.

(f) DELIVERY WITH INSURANCE: The date of delivery should be strictly adhered to failing which the

purchase order is liable to be cancelled. Penalty may be imposed as per P.O. terms & conditions. G oods should be securely, safely and adequately packed, insured& dispatched at the risk of supplie r and packing costs quoting this order reference should be kept in all package. Local firms are req uested to deliver the goods in our stores before 3.00 PM on any working day.

(g) All damaged or unapproved goods shall be returned at your cost & risk and the incidental expenses incurred thereon shall be recoverable from any of your bill.

(h) PERFORMANCE BANK GUARANTEE (PBG): The successful Bidder has to submit Performance Sec urity of 10% of the total order value on or after commission of equipment. Performance Security m ust valid f or 38 (Thirty Eight) months i.e. 2 months beyond the warranty period to cover the warra nty. Performance security is to be issued and sent directly from an Indian Scheduled/Nationalized bank. In case of non -submission of PBG, the equivalent amount will be kept on hold from the Bill a mount till completion of Warranty Period + 2 Months. PBG period will start from the date of the ins tallation.

(i) WARRANTY : 03 years Onsite OEM warranty for MW Pyrolysis, 05 Years onsite OEM warranty on Solar Panel, 25 Years performance OEM warranty on solar Panel(Minimum 90% and 80% of the sp e cified output for the first 10 years and remaining 15 years respectively), 03 years onsite OEM w arranty on Solar Inverter /PCU and 05 Years onsite OEM warranty for Solar Tubular Battery from th e date of installation/commission & acceptance by the user. In case at installation stores / part of stores are found defective / damaged during or after delivery to consignee, the supplier will replac e or repair the store under warranty at consignee's location free of cost or if any case it is require d to send back to foreign/Local manufacturer, supplier should bear the cost. The warranty period shall automatically be extended for suc h period for which the equipment is not attended & rectified on lapses of the down time.

(j). INSTALLATION : Installation & demonstration should be done by the supplier within 30 days of supply of the equipment failing which purchase order is liable to be cancelled/penalty may be imp osed as Purchase Order terms and conditions. In case the item ordered for is a machine/equipmen t the same should be successfully installed and commissioned immediately but in no case later tha n one month of the supply or the same. For delay in commissioning beyond 30 days scheduled per iod damaged as deemed appropriated may be deducted from the Bill / Agency Commission.

(k). LIQUIDATED DAMAGES: As time is the essence of this order, the date of delivery should be stri ctly adhered to, otherwise the delivery in full or in part may not be accepted and penalty for late d elivery will be imposed @ 0.5% of the contract value per week or part of the week of the delayed period, subject to a maximum of 10% of the total value of supply order & beyond 10% subject to a pproval of the Competent Authority of the Institute. In case of delay in installation the same rate o f penalty shall be leviable. In case of cancellation of order no compensation will be paid towards pr ogress of order/procurement.

(I) CANCELLATION: Printed conditions, if any, contained in or sent along with the quotation shall no t be binding on us. IIT Bhubaneswar reserves all the rights cancel the Purchase Order at any stage without assigning any reason thereof.

(m) JURISDICTION: This contract between the supplier and the buyer shall be governed by the LAW S of India and under this contract shall be taken by the parties only in Bhubaneswar, India to com petent jurisdiction.

(n) False declarations will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for up to two years as per Rule 151 (iii) of the General Finance Rules along with such other actions as may be permissibl e under law.
