#### Annexure-II Scope towards Repairing & Servicing of 500 KVA DG set installed at LCS-5 of IIT BHUBANESWAR, ARGUL CAMPUS.

- 1. The materials are to be supplied at site as per the schedule attached as **Annexure-I**. The vendor has to produce documents confirming the genuineness of the supplied materials and the concurrence for the same has to be produced from the OEM.
- 2. The supplied materials are to be replaced in the DG set. The old materials to be generated during the repairing & servicing of the DG set shall be handed over to the Institute.
- 3. Thorough maintenance of the DG set is to be carried out by the service engineerat site.
- 4. The entire lubrication system, filter assembly to be checked & serviced.
- 5. Visual inspection for any abnormality and its rectification.
- 6. Checking of the electrical system, radiator hoses, fuel line hoses, belt tension, battery voltage & its proper charging. In case the battery is not found healthy, the same will be arranged by the Institute.
- 7. After completion of the work, the DG needs to be operated & all the parameters needs to be recorded in the service report. Engine sound & smoke quality shall be checked in presence of the representative of the Institute.

a-The works shall be warranted for a period of 6 months from the date of completion against any defect.

b-During this period, the contractor has to provide the required service free of cost in bringing back the DG set to its normal operation.

c-During this period, if the supplied material is found defective, the same shall be replaced/repaired by the contractor free of cost.

In case the contractor fails to comply the above points during the warranty period, equivalent amount as assessed by the Engineer-in-charge will be deducted from the security deposit.

#### 14. Deviation of item/Non-Schedule item:

The rates for items required during the servicing (Items not covered in Annexure-I) of the DG set will be finalized based on the market rate analysis as per the proforma of schedule-F.

15. Performance Security: 5% of Tendered value shall be deposited by the successful bidder in the form of Demand Draft drawn in favour of Registrar, IIT Bhubaneswar payable at Bhubaneswar from any nationalized bank or same can be furnished in the form of Fixed Deposit Receipt of any scheduled Bank in favour of Registrar IIT Bhubaneswar within the period specified in Proforma of Schedule-F. In case the contractor fails to deposit the said performance security within the period as indicated in Schedule 'F' including the extended period, if any, EMD will be forfeited automatically without any notice to the contractor. The Performance security amount will be released after 30 days from the date of successful completion of the work. In case the time for completion of work gets enlarged, the contractor shall get the validity of Performance Security extended to IIT BBS's account in case of non-compliance of the terms & conditions of the tender. No interest shall be payable to the bidder against the performance security. If the agency does not start the work or does not perform the assigned work properly and/or in time as per the schedule, the deposits including performance security shall be forfeited.

In the event of the contract being determined or rescinded under provision of any of the Clause/Condition of the contract, the performance security shall stand forfeited in full and shall be absolutely at the disposal of the Director, IIT Bhubaneswar.

The time allowed for submission of the performance security shall be 7 days from the date of issue of "Letter of Intent" (LOI). This period can be further extended at the written request of the contractor by the Engineer-in-charge for a maximum period ranging from 1 to 7 days with a late fee @ 0.1% per day of Performance Security Amount. If the bidder still fails to deposit the performance security within the extended time period, i.e. within 8th day to 14th day from the issue of letter of Intent (LOI), his/her bid will be rejected and treated as cancelled and the entire Earnest Money Deposit shall be forfeited.

16. Security Deposit (SD): Security deposit @ 5% of the awarded value of the work will be deducted from the final bill and kept as security deposit by IIT Bhubaneswar. S.D can be

released after 2 months from the date of coverage of the warranty period on successful completion of the work.

#### 17. Return of EMD:

EMD will be returned to the unsuccessful bidder within 30 days from the date of award of the Work to the successful bidder or at the earliest after expiry of bid validity period. However, EMD will be returned to the successful bidder within 30 days from the date of submission of Performance Security Deposit to the Institute.

#### 18. Liquidated Damage:

Liquidated damage @ 0.5% on the value of work lagging behind per week of delay shall be levied subject to maximum 10% of Contract value.

- 19. The Bid for the work shall remain open for acceptance for a period of 90 days from the date of opening of bid. If any bidder withdraws his Bid before the said period or issue of letter of acceptance whichever is earlier, or makes any modification in the terms and conditions of the bid which are not acceptable to the Institute, then the Institute shall, without prejudice to any other right or remedy, be at liberty to forfeit the Earnest Money. Further the bidders shall not be allowed to participate in the re-bidding process.
- 20. The Notice Inviting Bid shall form a part of the contract document.
- 21. Place of Work: The entire work is to be taken up at IIT Bhubaneswar campus at Argul, Jatani.
- 22. Site Inspection by the Bidders: The tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of site, the means of access to the site and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools and plants, accommodation, facilities for the workers and all other services required for executing the work.
- 23. **Safety**: All safety measures are to be followed by the contractor while execution of the contract & safety standard shall be followed as per IE(Indian Electricity) rule, while working on Electrical system. The Institute does not hold responsibility for any untoward situation arising out due to violation of safety rules. Work permit shall be obtained from IIT BBS before taking up the work. The DG set will be made off/isolated during maintenance to ensure safety

Trained technician/engineer shall be deployed at site & the work shall be carried out as per OEM's standard. On non-adherence of this clause, suitable fines shall be imposed as decided by the engineer in charge. But, in no case the fine imposed by the Institute exceeds the contract value. The Institute will not be liable for payment of any compensation against any personal accident of contractor's employee.

24. IIT will not be responsible or liable in case of any accidental injury to the personnel of the contractor at work site or to the general public at work site due to mishandling/improper work

execution by the personnel of the contractor. Workmen compensation, PF, ESI of the employees shall be taken care by the contractor.

- 25. After completion of work, area to be thoroughly cleaned by the contractor and the waste are to be taken out by the contractor through proper waste management.
- 26. It will be the sole responsibility of the Contractor to abide by the provisions of the following acts as to the workers engaged by him for performance of this contract:
  - Employment of Children Act
  - Workmen Compensation Act
  - > Employment of Labour / Contract Labour Act
  - Industrial Employment Act
  - Contract Labour Abolition and Regulation Act 1970
  - Minimum Wages Act
  - Employee Provident Fund Act.
  - > Any other act or legislation which may govern the nature of the contract.
- 27. The Contractor shall be liable to pay compensation for any loss and damage caused to the property of IIT BHUBANESWAR. The damages made must be rectified by the contractor without any extra cost. In case, the rectification will not be done by the contractor, equivalent amount will be deducted from the Bill of the contractor. The cost for the same will be assessed by tender accepting authority and will be limited to the tendered amount.
- 28. Engineer & Workmanship: The Engineer/Supervisor/Technician/Helper to be deployed at site must have experience in execution of similar work. They must have expertise in DG set maintenance work. The engineer/Supervisor, Technician & helper must be present during execution of the work. However, if the Institute feels to replace any of the person because of any reason, the same must be done by the contractor on intimation from IIT BBS.
- 29. **Gate Pass**: The contractor must issue/ submit ID proof of all the workers to be deployed at site for entry pass at the time of entry inside the campus.

#### **30. COVID Measures:**

The contractor has to strictly adhere to the Institute SOP in view of COVID. Revision in the SOP will be intimated/communicated to the contractor from time to time by the Institute & the contractor has to follow the same during the contract period. The Institute will not bear any additional cost on account of the COVID measures to be taken by the contractor to comply the Institute SOP.

31. The successful bidder has to submit the detailed address (includes e-mail address) to IIT BBS for necessary official correspondence after award of the contract.

#### 32. Risk Purchase:

In the event of Contractor's failure to execute the contract to the satisfaction of the Institute, the Institute reserves the right:

a-To terminate the Contract and to get the Contract executed by other agency at the risk and cost of the Contractor.

- 33. The Institute reserves the right to cancel the tender at any time without assigning any reason thereof.
- 34. Corrigendum /Addendum notice if any, will only be uploaded in the web site of IIT Bhubaneswar www.iitbbs.ac.in (Tenders) & in <u>https://eprocure.gov.in/eprocure/app</u>. There will be no press publication in this regard. Bidders are required to check the Corrigendum /Addendum notice if any in our web site, before finally submitting the bid.
- 35. **Jurisdiction of the Court**: Dispute/Litigation if any, arising out of this contract, shall be deemed to have been entered into at Bhubaneswar under jurisdiction of Odisha High Court, Cuttack.
