#### **ANTI•RAGGING MEASURES**

Ragging, in any form, is totally banned in the Institute and its Hostels.

Anyone indulging in such acts shall be subjected to punishment by the Concerned authorities and/or a Court of Law

#### WHAT IS RAGGING?

"Ragging" means causing, inducing, compelling and/or forcing a Student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity, or violated his/her person, or to expose him/her to ridicule, or to forebear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining, or injuring him/her, or by using criminal force to him/her, or by holding out to him/her any threat of such intimidation, wrongful restraint, wrongful confinement, injury, or the use of criminal force.

#### SUPREMECOURTVERDICTFORSTRINGENTACTION INCASEOFRAGGING:

Supreme Court of India in its recent direction to the educational institutions pronounced that all educational institutions should obtain an UNDERTAKING from each candidate at the time of admission to the effect that, he/she is aware of the system of punishment in case of ragging to other students. And that, in case he/she is involved in any case of ragging ,he/she is aware of this scale of punishments, including criminal action, cancellation of admission ,expulsion from hostel, withdrawal of scholarship, imposition of fine up to Rs.25,000/-,and/or rigorous imprisonment up to 3(three) years, etc.

All candidates and their parents/guardians, in their own interest, are advised to make themselves acquainted with the relevant rules, regulations, provisions of law, as well as decisions of various Courts of Law, including those of the Apex Court, in relation to antiragging measures in India.
