विषय / Subject: Remission of Tuition fees (Fresh) for the academic year 2023-24.

The following B.Tech / Dual Degree students of 2023 admitted batch have been awarded Remission of Tuition fees (Full & 2/3rd) for the Academic year 2023-24, respectively as given in **Annexure-I** (enclosed).

1. The eligible students (**enlisted in Annexure- I**) who have paid the Tuition Fees for the Autumn Semester 2023-24 may be reimbursed Rs. **1,00,000/-** (For Full Tuition Fees Remission) and Rs. **66,666/-** (for 2/3rd Tuition Fees Remission) respectively.
1. The eligible students (**enlisted in Annexure-I**) will pay the balance amount of registration fees in the Spring Semester 2023-24 after deducting **Rs. 1,00,000/-** (for Full Tuition Fees Remission) and **Rs. 66,666/-** (For 2/3rd Tuition Fees Remission).
2. The students who are provisionally selected (**enlisted in Annexure-II**) shall pay the full amount of registration fees in Spring Semester 2023-24. The students who will submit the required documents before the stipulated time, they shall be exempted from paying the Tuition Fees for Spring Semester. If they failed to submit the documents before the time limit, they shall pay the full amount of Tuition Fees in the Spring Semester and the same will be reimbursed after submission of required documents and confirmation from the Academic Section.
